## ORDINANCE NO. 2014-01 LOWER FRANKFORD TOWNSHIP CUMBERLAND COUNTY, PENNSYLVANIA

## AN ORDINANCE ESTABLISHING RULES AND REGULATIONS FOR PARKS AND RECREATION FACILITIES.

It is hereby enacted by the Board of Supervisors of Lower Frankford Township, Cumberland County, Pennsylvania as follows:

- Section 1. <u>Regulations for Parks and Recreation Facilities</u>. The parks and recreation facilities leased by the Township for recreational purposes, hereinafter referred to as "Areas", shall be governed by the rules and regulations contained in this Ordinance.
- Section 2. <u>Application; Authority for Additional Regulations</u>. Rules and regulations set forth herein are hereby promulgated to be effective immediately and to apply to the use of Areas. The Board of Supervisors is authorized to prepare and approve by Resolution additional rules and regulations and also modify the rules and regulations set forth herein .
  - Section 3. Hours. Recreation Areas, are open to the public between 5 AM to 10 PM.
  - Section 4. Prohibited Acts. The following acts and conduct are prohibited in Areas:
    - A. Boisterous, immoral, or indecent conduct.
    - B. Discarding of trash, garbage, or other litter, except into containers provided for that purpose.
    - C. Damaging, defacing, destroying, or removing any Township owned/leased property, sign, structure, equipment, or other material; driving nails or other hardware into trees.
    - D. Posting of signs; distributing, selling, servicing, or renting of any supplies, equipment, material, or commodity whatsoever, or soliciting for any purpose, without written authorization from the Township Supervisors.
    - E. Operating, stopping, or parking of any vehicle or bicycle, except on designated roads, trails, or Areas.
    - F. Operating any vehicle or bicycle in a reckless or negligent manner, or in excess of the speed limit of 15 mph, or in such a manner as to become a nuisance to other Area users; parking any vehicle in Areas of prohibited parking, as posted by the Township.
    - G. Possession of fireworks, except in transit in vehicle operated or owned by person.
    - H. A safety zone of 150 yard from the pit toilet and pavilion for all types of firearms.
    - I. Picnicking, and use of all fires, except in designated Areas and facilities. No open fires permitted. Gas and charcoal grills are permitted.

Section 5. <u>Authority to Establish Priority of Events.</u> The Board of Supervisors shall have authority to establish priority and to schedule all events in designated Areas.

Section 6. <u>Authority to Close Areas.</u> Area facilities which become hazardous for public use due to weather, water, fire or unforeseeable conditions, may be closed at the discretion of the Board of Supervisors only.

Section 7. <u>Penalty for Violation.</u> Any person who shall violate any provision of this Ordinance, upon conviction thereof, be sentence to pay a fine of not less than twenty-five dollars (\$25) nor more than three hundred dollars (\$300) and costs of prosecution, or, in default of payment of such fine and costs, to undergo imprisonment for not more than thirty (30) days.

Section 8. <u>Severability.</u> The provisions of this Ordinance shall be severable, and if any of its provisions shall be held to be unconstitutional, illegal or invalid, such decision shall not affect the validity of any of the remaining provisions of this Ordinance. It is hereby declared as legislative intent that this Ordinance would have been adopted had such unconstitutional, illegal or invalid provision not been included herein.
